Subject: Israel-Lebanon Crisis

The Security Council,

Noting Chapter I of the United Nations (UN) Charter which directs the UN to preserve peace,

Recognizes the crisis on the Israeli-Lebanese border which requires immediate attention and action taken by the Security Council to prevent conflict,

Emphasizing previous resolutions S/RES/1701, S/RES/1559, S/RES/1553, and S/RES/1525,

Recognizing the implications of violence on the borders of Israel and Lebanon which has created increasing disaster on mass civilian regions,

1. *Calls for* an immediate ceasefire of all conflict and military operations on the Israeli-Lebanese border by all actors be them Member State or non-state actors to include:
 - a. Administering an immediate ceasefire in effect for 72 hours along the borders of Israel and Lebanon enforced by the United Nations Interim Force in Lebanon (UNIFIL),
 - b. Directing a ceasefire of hostilities along the political border of Israel and Lebanon through the imposition of a no-fly zone enforced by UNIFIL encompassing 120.7 KM (75 Miles) in size in each direction of internationally recognized political borders, as well as zones under claim from multiple nations. The no fly zone will occur at 12:00 AM Eastern European Summer Time (CST +8) March 29, 2021, and stand for 72 hours for the purpose of establishing the intent of peaceful diplomacy,
 - c. Invoking economic sanctions for any violators in accordance to Chapter 7 of the UN Charter, and,
 - d. Directing an additional 4,356 UN peacekeeping troops to UNIFIL to enforce the immediate ceasefire;

2. *Creates* an emergency roundtable session of the governments of Israel and Lebanon and the UN Security Council during the ceasefire, and:
 - a. Invites any Member State and non-state actors that desires to attend the roundtable with the approval of the Security Council President, and,

- b. Urges the roundtable to produce a continued ceasefire along the Israeli-Lebanese border;
3. *Rejects* any further military action by any Member State or non-state actors along the Israeli-Lebanese border as listed below, including but not limited to,
 - a. Any aggression as defined by A/RES/29/3314,
 - b. The mobilization of troops within or towards the Israeli-Lebanese border; and,
 - c. Violations of Article 39 of the UN Charter,
4. *Approves* the use of resources from the Office for the Coordination of Humanitarian Affairs (OCHA) in a joint humanitarian mission into the conflict zone following attacks from the Israeli-Lebanese conflict by:
 - a. Combining the aid from individual Member States along with the UN humanitarian aid in delivering medical aid and emergency relief,
 - b. Establishing temporary field hospitals to treat the injured,
 - c. Providing food, water, and medical supplies to be distributed by UNIFIL peacekeepers in the region alongside OCHA agent along the Israeli-Lebanese border,
 - d. Facilitating evacuations to be conducted by UNIFIL peacekeepers along the Israeli-Lebanese border to help civilians flee from the ongoing violence at the discretion of the UN Department of Peacekeeping Forces, and,
 - e. Rebuilding damaged water infrastructure and supply routes in the UNIFIL Area of Operation as determined by the United Nations Development Programme's Funding Facility for Stabilization;
5. *Invites* a UN-approved investigation led by INTERPOL of the bombing of the Israeli Embassy in Greece, in cooperation with Hellenic Police and the expressed consent of the Government of Greece to take place immediately; and,
6. *Creates* a summit of Member States with the Member States of the Security Council to discuss the security issues in the Israeli-Lebanese border, in which:
 - a. Member State representatives are to be decided and approved by the President of the Security Council,
 - b. Shall first convene on the 15th of April, and,
 - c. The first meeting shall be virtual, subsequent meeting locations and dates as to be determined by the summit members.
